The Chairman, Cabinet Appointed Procurement Committee, Ministry of Transport Services Management, Seventh Floor, Stage II, Sethsiripaya, Battaramulla, Sri Lanka is hereby inviting sealed Bids from the eligible bidders for the '**Complete Solution for Driving License Information System, Personalization and Printing**' for Department of Motor Traffic, Sri Lanka. The method of procurement for this procurement shall be 'International Competitive Bidding - ICB'. The currency of bid shall be in Sri Lankan Rupees.
2. The scope of this procurement includes 'Designing, Developing, Testing, Installing, Commissioning, Operating and Maintaining the above Information System under (Build-Own-Operate) BOO Model. The requirements and related specifications are described in detailed in the bidding document.
