

APPLICATION FOR A NEW PASSPORT IN LIEU OF LOST PASSPORT

If your passport is lost, it is the responsibility of the holder to inform the concerned authorities immediately. Failure to do so may result in your passport being used for illegal activities, and you may be liable for aiding and abetting an offence.

Instructions

1. When your passport is realised to be lost or stolen, **immediately make a complaint to your local police station** in your country of residence. Obtain a **Police Report (Statutory Declaration)**.
2. **Photographs**
 - Please make sure that your glasses/hats or caps are removed.
 - Both ears and the forehead should be clearly visible.
 - if you send the application via post, one of your photographs pasted on page 2 of the application need to be certified by an authorised Australian certification bodies. (Please see instructions below for further details)
3. Attestations are not required if documents are submitted directly to the Consulate office by Applicant. Forms should be signed only before an authorized officer of the Consulate.
4. If you are **above 16 years of age** and if you have **not yet obtained a Sri Lankan Identity Card**, a letter should be submitted by you stating your consent to obtain a new Identity Card upon your first entry to Sri Lanka. This letter should be addressed to the "Controller General, Department of Immigration and Emigration, Sri Lanka"
5. **Dual Citizenship Applicant under Retention category** – If you have not yet obtained a foreign passport, you should submit a letter confirming that. This letter should be addressed to the "Controller General, Department of Immigration and Emigration, Sri Lanka"

Payment should be made in Cash at the Counter

- **New Passport Fee: AUD 541** (if a photocopy of the Bio-Data page of the lost passport is available)
- **New Passport Fee: AUD 683** (if a photocopy of the Bio-Data page of the lost passport is unavailable)
 - **Personal/Company cheques and Credit/debit Cards are not accepted.**

If you wish to submit the documents by Post; Application (page 4), copies of all other required documents and one of your photographs pasted on page 2 of the application need to be certified by an authorized Australian certification bodies (Lawyer, Doctor, Justice of Peace, Police Officer or Pharmacist).

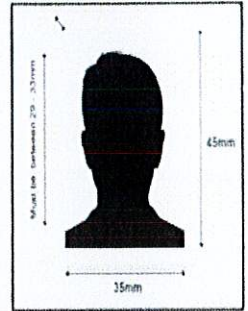
