- Attestations are not required if documents are submitted directly to the Consulate office by Applicant. Forms should be signed only before an authorized officer of the Consulate.
- If you wish to submit the documents by Post, Application and copies of all other required documents need to be certified (with an official stamp) by an authorized Australian certification bodies. (Attorney-at-law, Notary Public, Doctor, Justice of Peace, Police Officer or Pharmacist).
