2. Bidding will be conducted through **International Competitive Bidding (ICB)** procedure and tender mentioned in above para 01 is subjected to two envelop bidding method.
3. Bidders should meet the following minimum qualification criteria.
- Offered goods should be originally manufactured by Original Equipment Manufacturer (OEM) and should available OEM confirmation for service support.
 - If a bidder is a foreign bidder and not doing business in Sri Lanka, should have a legally registered business presence of its authorized agent in Sri Lanka.
 - To be provided manufacturer's printed Technical Brochures.
 - Copy of Agreement (in case of Partnership / Joint Venture).
 - Power of Attorney (when and where relevant).
 - Minimum Average Annual Turnover of the bidder shall be 1.5 times of the bid price for the last 3 consecutive years.
 - Foreign bidders shall be registered company/ entity in the perspective countries and shall have been operation for the last three (3) years.
 - Bidder must have completed similar kind of business transaction during last three years.
 - Bidder and agent shall have skilled and technically competent team certified by bidder's country civil aviation authority to carry out necessary warranty support and maintenance and after sales services as required by the purchaser during the period of warranty.
